# On Target

Brian Weston assumed the stewardship of the Sir Richard Williams Foundation, On Target column, from Alan Stephens in March 2017.

Subsequently, 22 columns were published in Australian Aviation (15 authored by Weston, 7 by Stephens) with the last column published in March 2019.

After moving to the Australian Defence Business Review, 17 columns were published in Australian Defence Business Review – the first in March 2019, the last in Jan/Feb 2022. Along the way, the Board endorsed the following updated guidance for On Target, commencing in calendar year 2020:

- Sensitise Australians that the nation's geo-strategic and national security environment has changed, dramatically.
- Impress on government, and taxpayers, that national security funding needs to be modestly increased.
- Observe large expenditures on major defence capabilities that cannot deliver in the near term, are of little utility in countering a threat that is materialising rapidly.
- Argue defence expenditure should be prioritised on evolving those current capabilities where significant gains in capability, in the short term, can be achieved.
- Caution that while technological trends indicate rapid advances in military and national security
  capabilities are possible, the pace and utility of these technological advances is difficult to predict;
  hence, prudent judgement is required in evaluating evolving threats and in investing in new technologies
  that enhance national security.

Following the expansion of online publishing and of the gradual demise in print publication, the column's partnership with the Australian Defence Business Review ended with the last edition of Australian Defence Business Review in Jan/Feb 2022.

While it is now time for a new policy to guide the evolution of the On Target initiative, the Sir Richard Williams Foundation acknowledges and thanks both Australian Aviation and Australian Defence Business Review for the support provided to the foundation's On Target column over a long period and of course Brian Weston who has tireless produced this important contribution to the Williams Foundation.

Over the coming year we will look at options --- we might pursue is the establishment of a dynamic online inter-active presence with an experienced defence professional moderating a new On Target 'conversation' forum.

# Air Power Scholars Program

The Air Power Scholars program is a cooperative endeavour between the Foundation and the Air Power Development Centre. It aims to develop a small group of Air Force Officers with the intellectual skills, theoretical knowledge, and practical experience to engage credibly in the global air and space power



dialogue. Currently 5 PhD candidates are supported by the Air Power Development Centre and the Foundation. \$20,000 can be accessed by each PhD candidate over the course of their research.

AVM Steve Edgely was awarded his PhD this year and CAF held a small Ceremony to celebrate the event. AVM Edgely's thesis was The Royal Australian Air Force's Struggle to Create Joint Military Capability: A Study of the Evolution of Inter-Service Cooperation in the Australian Defence Force ---- 390 page with some great case studies on the Canadian and Israeli Defence Force experiences

In 2021/2022 Kate Yaxley used the grant money to progress her PhD and is well on her way to completion. In 2022/23 SQNLDR Sally Knox commenced full time university to work on her PhD.

# Item 6.The Central Blue Update – Geoff Brown

The Central Blue is a forum designed to promote informed discussion and debate about air power issues affecting Australia. Its scope is broad, covering topics from tactical integration to strategic theory, and from historical lessons to future capabilities. Submissions are welcome from any source but particularly from serving military practitioners with the aim of fostering a new generation of air power thinkers. The blog is updated regularly – usually once a week – with articles on various aerospace and national security issues.



#### Editorial Team.

TCB's editorial team consists of six full members, Jenna Higgins, Amy Hestermann-Crane, Ulie Yildirim, Luke Webb, Jason Begley and Jo Brick, plus 3 interns, Rebecca Durbin, Ross Tindale & Grace Scholl. Except for Luke Webb, the team are all serving members of the RAAF.

#### **Publishing**

The Central Blue published 26 original pieces over the past 12 months. The top 10 articles published in the last 12 months (in order) are:

#### Writing calls

Over the past 12 months TCB has had three key writing foci:

- #FutureChiefs: Asking prospective authors to share what they think future Chiefs of Air Force should look like, and why
- #FailureWins: A call for articles about innovation, experimentation, and failure culture in the military context
- #FightReady: Asking prospective authors about their ideas & recommendations for the Defence Strategic review

#### Writing prize

The 2021 Dr Alan Stephens Air Power Literary Prize was awarded for very a unique piece by Wing Commander (WGCDR) Travis Hallen and his daughter. The piece, *Losing Jefferson*, used science fiction to explore the future of autonomous drones while challenging humans ability to trust and connect with machines. Honourable mentions were given to Squadron Leader (SQNLDR) Brendon Bishop and his Case for a Universal Multi-Domain Shipping Contain and to Ben Luther's Assuring 2121 which challenged Test and Evaluation thinking.

#### Impact & future workplan

As part of the broader Foundation, TCB offers an intentional, independent platform for original ideas, particularly by junior ADF personnel, that can generate meaningful debate and change within the ADF. Several writers have been able to generate substantial discussion and efforts towards change in areas such as training, workforce structure, innovation/industry policy, acquisition processes, and engineering governance. The work of our authors captures the attention of Service Chiefs.



Over the past 12 months, the editorial team engaged in several reflective conversations about how to advance The Central Blue's mission, model, and formats. A work plan for 2023 is being devised to encapsulate these discussions and will underpin future team recruitment calls in the new year.

#### Reach

Over the past 12 months, TCB has continued to grow and engage with our audience base via three social media channels (LinkedIn, Twitter & Facebook). Whilst the leading location of our audience is Canberra, we also have a strong following in other Australian capitals (Melbourne, Adelaide & Brisbane), and have about a quarter of our audience located overseas.

# Item 7. 2021/22 Annual Financial and Treasurers' Report – Ken Moore

- 1) The Foundation's 2021/22 Annual Financial Statements have been finalised and provided to Members.
- 2) The Chair and I have signed the Statements including, on behalf of Members, that the Foundation is a going concern. We have also certified that the Statements give a true and fair view of the financial position and performance of the Foundation during and at the end of the 2021/2022 financial year.
- 3) Our Auditor, Michael Sinclair, has issued an unqualified Audit Report.
- 4) Our Operating Result for the FY, a surplus of \$45,866, is detailed in the Income and Expenditure Statement. This can be compared with a deficit of \$107,958 in the 2020/2021 FY.
- 5) Some comments on the financial results:
  - a. The Foundation is in a healthy financial position with \$527,460 in cash reserves, as shown in the Balance Sheet, which can be compared to our total expenditure in the FY of \$267,772, as shown in the Income and Expenditure Statement. This reflects the Board's strategy of having sufficient funding available for staging two years of activities if our income from members and sponsors was curtailed.
  - b. The financials reflect the resumption of the normal tempo of activities post COVID restrictions. The Foundation held two seminars (The Requirements of a Sovereign Defence Space Capability on 1 December 2021, and Shaping the Way Ahead for the Networked,



- Integrated Force on 24 March 2022) and four lunches (with three topics). All events were well attended and well received by participants.
- c. At the last AGM, I advised Members that the Board anticipated that the Foundation would receive about \$437,000 from the Air Force grant and membership and sponsorship fees. Actual income from these sources was \$312,364. Two major explanations:
  - I. Slippage of some membership and sponsorship fee payments from last FY to this FY (about \$88,000).
  - II. A reduction in forecast sponsorship for one company for one of the seminars from Gold to Bronze (\$20,000).
- d. This largely explains the difference in the forecast surplus of \$170,000 that I advised at the last AGM and the actual surplus of \$45,866 for the FY.
- e. The good news is that the slippage of these membership and sponsorship fee payments, and some other variations in income and expenditure from last FY, have resulted in a forecast operating surplus of \$130,639. This as usual is heavily dependent on the Foundation maintaining its current level of sponsors and members.
- f. If the forecast holds true, our cash reserves on 30 June 2023 will be \$670,369. An even healthier position than 30 June 2022.
- g. Income from the Air Force grant and membership and sponsorship fees in all FYs must cover the cost of our events and our other running costs, such as accounting and audit fees, business management (mainly for our part-time business manager and social media adviser), business expenses, insurances, IT and software, marketing, the Air Force Scholars Program and the Writers' Prize.
- h. A big thanks to Cath Scott for keeping our financial records so well and to our Auditor, Michael Sinclair.
- i. Any questions?
- j. I commend the Annual Financial Statements to Members.
- k. I move the Statements be accepted.

# Item 8. Special Resolutions – Nicole Quinn

# Proposed Special Resolution – Chair and Deputy Chair Re-Election

To ensure full probity, the Chair and Deputy Chair abstained from consideration of the Special Resolution and voting on it. For this item, Members present are asked to agree to the appointment of the Secretary as Acting Chair.

#### **Purpose**

To seek the AGM's endorsement to a proposed Constitution amendment to allow the current Chair and Deputy Chair to nominate for re-election to their respective offices.



#### Background

The current Constitution states in the last sentence of section 5.1.3 that "Directors are eligible for re-election but may not hold office as Chair or Deputy Chair for more than three consecutive terms of two years".

The current Chair and Deputy Chair have held their respective offices for three consecutive terms of two years and cannot nominate for re-election to their current offices at this AGM.

The current Chair and Deputy Chair have indicated a willingness to nominate for their respective offices if a practical solution can be found. They are of the view that section 5.1.3 provides a useful governance safeguard and should be retained if possible.

#### **Chair and Deputy Chair Succession Planning**

The Chair and Deputy Chair have led the Board extremely well over their tenure including through the pandemic lockdown. The Foundation is in a strong position in terms of its contribution to the national security debate and financial robustness.

Normally, the Deputy Chair would be in consideration for Chair but ACM Binskin has advised that, due to other work commitments, he does not have the time for the Chair's role.

No better qualified Directors have been identified who can put in the same level of commitment as the current Chair and Deputy Chair.

The Board intends to actively pursue succession planning over the next two years for the Chair and Deputy Chair positions.

# **Proposed Amendment**

The Board proposes that the safeguard of section 5.1.3 in the Constitution be retained, with the following caveat added: "Unless Directors agree otherwise..."

Should Members agree with the proposed amendment, the last sentence of section 5.1.3 of the Constitution would read:

"Directors are eligible for re-election but, unless Directors agree otherwise, the Chair and Deputy Chair may not hold office for more than three consecutive terms of two years."

# **Board Agreement**

In preparation of Members' consideration of this Special Resolution, Directors "agreed otherwise" at the Board meeting on 31 August 2022. This paves the way for the current Chair and Deputy Chair to hold office for more than three consecutive terms of two years should their nominations at the AGM be successful.

This Board agreement only takes effect if Members agree the proposed amendment to the Constitution.

#### Recommendation

That Members agree to amend section 5.1.3 of the Constitution by rewording the last sentence as follows: "Directors are eligible for re-election but, unless Directors agree otherwise, the Chair and Deputy Chair may not hold office for more than three consecutive terms of two years."



One question was asked by a member regarding who has control - directors or members? Ken Moore clarified that it is the members who have control.
